

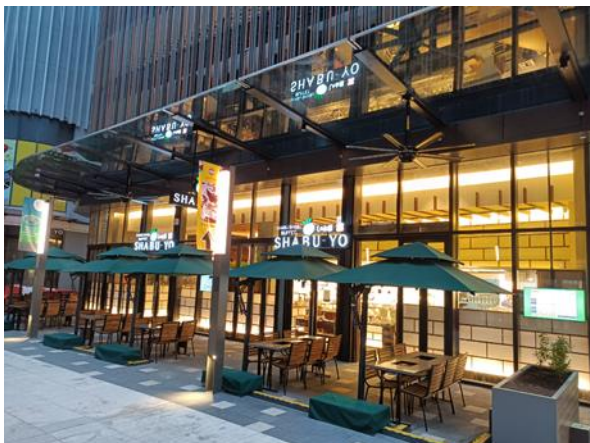
Skylark Opened the Third Shabu-shabu Restaurant in Malaysia

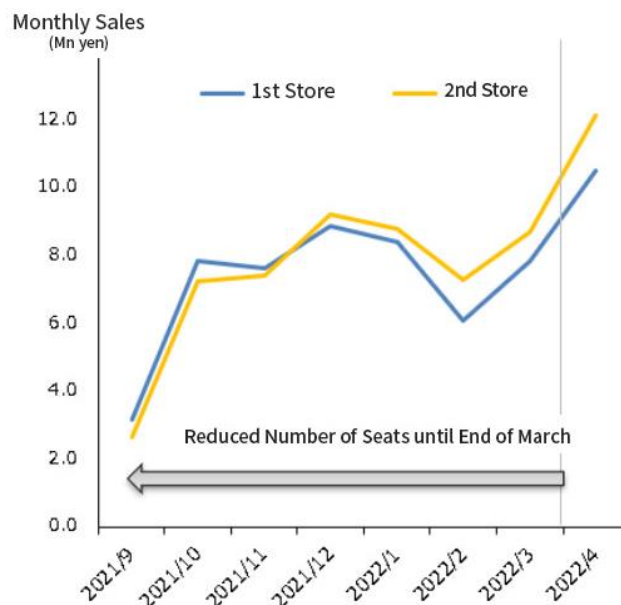
